## Thinking of Selling Your Home?

We wanted to remind Preserve residents that if you plan to sell your home, it is the seller's obligation to provide a Resale Disclosure Certificate to the buyer of any Lot in a homeowners association. State law gives the homeowners association 10 days to

complete the request and allows us to charge a fee. There is a fee to provide the certificate and documents.

Prior to closing the title company may request that the Association complete a Dues Current letter. We request 10 days to process this document and there is a fee that may be collected at closing.

(Rush fee may apply if documents are required within 48 hours.)

Note: Some Preserve residents have two homeowners associations so make sure to disclose both. We are the common property association.

## City of Eden Prairie Policies Regarding Parking

•Unless there is a sign stating "no parking" vehicles may park on the edge of public streets. All vehicles parked on public streets must have current license tabs and be operable. Vehicles must be moved every 24 hours.

•All vehicles parked on private property must have current license tabs and be operable. All parking must occur on a hard-surfaced area of cement or asphalt. No parking may occur on grass or snow-covered areas. Vehicles that are not operable or registered may be stored inside a garage. In the Residential districts, trucks with commercial licenses or over a certain weight may not be parked on private property.

•The city prohibits parking on city streets after a 2-inch or more snowfall until the streets have been plowed to full width.

• Preserve Parking Policies: Storage of infrequently used vehicles, boats, snowmobiles, trailers, campers, excess material or equipment is prohibited by the covenants.

#### Emerald Ash Borer



There are almost a billion ash trees in Minnesota, more than any other state. This month's cold weather may have had at least one upside. It was so cold for such an extended period that up to 80 percent of invasive emerald ash borers may have died. The cold won't be enough to stop the invasive beetle's spread, but it will give us a little more time to replace or treat ash trees. The emerald ash borer seems to be spreading in Minnesota more slowly than in other states, perhaps because of early detection and community remediation efforts, along with the cold weather. We estimate that the Preserve common grounds has approximately 2,000 ash trees and we continue to monitor the ash borer situation.

#### Value of Trees: (Information from the Minnesota Landscape Arboretum)

- Trees can reduce home cooling costs up to 40% if planted to the west and south of a house.
- Trees capture rainfall and reduce storm water runoff, erosion, and pollution with an average city tree capable of capturing nearly 1,700 gallons of water each year.
- Trees store carbon dioxide to make sugar for food and energy. Emission reduction through photosynthesis is valued at \$4.31 per tree annually. The City of Minneapolis with nearly 200,000 trees saves \$857,000 in energy savings annually.
- Children's activities in a park with trees may improve ADHD (Attention Deficit Hypersensitivity Disorder) symptoms.
