o Finance:

- Tree Maintenance is \$20k over budget YTD due to EAB.

Pool update

- Swim Memberships down 32% following two straight record years.
- Lessons down 15% from last year's record year.
- Swim lessons, session 1 starting June 17.
- Pipe repair seems solid. Some water still leaking from the wall in mechanical room.
- Decking over pipes installed.

Grounds update

- 300 seedling trees in process of planting and will be done by the weekend. State reimbursement inspection EOM. Forester will be coming out to confirm work was done.
- Gardens are cleaned out and growing.
- Path repaying is complete.
